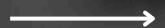

# Investment Opportunities

The Sustainable Island State Contribution (SISC) is a non-refundable financial contribution made directly to the St. Kitts and Nevis government. This contribution supports national growth initiatives including education, healthcare, tourism, climate resilience, and economic diversification.

## **Contribution Amounts:**

- \$ 2,50,000 :Main Applicant with up to three qualifying dependents
- \$ 25,000 :Each additional dependent after family of 4 but under 18
- \$ 50,000 :Each additional dependent after family of 4 but 18 yrs old & over

## **Key Points:**

- Funds are used to improve national infrastructure and services.
- Fastest and simplest investment option.
- No additional real estate or business obligations.

## **2. Real Estate Investment**

Applicants can obtain citizenship by investing in designated, government-approved real estate projects, such as luxury hotels, resorts, or villas.

## **Investment Options:**

- Purchase Real Estate Worth at Least \$325,000 USD
- (Property must be held for a minimum of 7 years before resale.)
